KNOW ALL MEN BY THESE PRESENTS: That the undersigned, GEORGE D. WYSE, of legal age, does hereby sign and acknowledge these Articles of Incorporation for the purpose of forming a corporation under the provisions of Title 24, Chapter 03, Revised Code of Washington, and pursuant to the laws of the State of Washington, and states as follows:

I

The name of this corporation shall be MADRONA BEACH COMMUNITY WATER SYSTEM.

ΙI

This corporation shall not engage in any activities which will result in financial gain to it or its members. Subject to said limitation, the purposes for which this corporation is formed are as follows:

To supply the members of this corporation with water and to accomplish this purpose to tap springs, sink wells, and otherwise acquire water; to make, build, construct, purchase or otherwise acquire and erect or lay down and maintain tanks, reservoirs, cisterns, culverts, ducts, pipes, conduits, filter beds, purification facilities and other appliances necessary and appurtenant to this purpose, and to execute and do all other works and things necessary or convenient for obtaining, storing, delivering, measuring and distributing water, or otherwise for the purposes of the corporation;

To control, regulate, supervise, improve, or direct the control, regulation, supervision and improvement of community areas, well sites or park areas acquired by the corporation or established in or near the Plat of Madrona Beach, Plat of Madrona Heights, or any Addition or Division thereto.

To encourage and assist in the acquisition of public lighting for streets, alleys, parking lots, beaches, parks, private roads, trails, and other public areas in or near the Plat of Madrona Beach, Plat of Madrona Heights, or any Addition or Division thereto.

To acquire, maintain, manage and control buildings and property for community educational and recreational facilities; to engage in any and all types of activities not prohibited by law which shall tend to raise the standards of civic morality and community welfare of the members and friends of the corporation by the promotion of educational, recreational and social facilities;

To purchase, lease from others, and otherwise acquire, sell, convey, transfer, lease to others, and otherwise dispose of, mort-gage or otherwise encumber real and personal property belonging to the corporation;

To do all things necessary, suitable and proper to accomplish any of the purposes or to attain any of the objects herein set forth, and to do all acts or things incidental or appurtenant to or growing out of or connected with the aforesaid objects or purposes, or any part or parts thereof, provided such be consistent with the statute under which this corporation is formed.

III

This corporation shall continue perpetually.

IV

The address of the initial registered office of the corporation shall be 165 North, 960 West, Camano Island, Washington 98292. The name of the initial registered agent of the corporation at such address shall be George D. Wyse.

V

The number of trustees constituting the initial board of trustees of the corporation shall be five (5) trustees. The names and addresses of the persons who are to serve as the initial trustees of the corporation are as follows:

VI

The members of this corporation shall be individuals, the interest of each to be equal and none may acquire any interest which would entitle him to any greater voice, vote, authority or interest in the corporation than any other member.

VII

There shall be no capital stock and no shares shall be issued, but each member shall be entitled to hold a membership certificate or certificates which shall carry such priviliges and be assignable as provided for in the bylaws.

## VIII

The name and address of the incorporator of this corporation is George D. Wyse, 165 North, 960 West, Camano Island, Washington 98292.

IX

In the event the corporation is dissolved, the net assets of the corporation shall be distributed, share and share alike to all of the then members of the corporation on a pro-rata basis, EXCEPT for those assets held by the corporation upon conditions requiring return, transfer or conveyance, which condition occurs by reason of the dissolution, and said assets shall be returned, transferred or conveyed in accordance with such requirements.
